RE: Support for Legislation to Create a Well-Regulated Marketplace for the Sale of Legal Vapor Products in Florida

Juul Labs is on a mission to transition the world's billion adult smokers away from combustible cigarettes, eliminate their use, and combat underage usage of our products.

We strongly support the introduction of SB 1006 and HB 1007 to create a well-regulated marketplace for the sale of legal vapor products in Florida. We applaud Chairman Perry and Chairman Overdorf for the introduction of these bills.

Creating a Well-Regulated Marketplace in Florida

Juul Labs is committed to upholding and participating in a well-regulated nicotine marketplace across the United States and in Florida. We have invested significantly in product development, regulatory science, manufacturing quality controls, and compliance programs. We believe all companies participating in the nicotine vapor market should be doing the same, to ensure that the products reaching consumers are of the highest quality and are only reaching intended users – adult smokers.

For Florida lawmakers who are new to Juul Labs, we want to ensure you have all the relevant facts about our company.

 Juul Labs made a commitment in 2019 to earn the trust of key stakeholders in service of its mission. We have seen significant progress – middle and high school student use of JUUL

products was down 97% in 2023 from its high in 2019, according to the latest National Youth Tobacco Survey (NYTS) <u>data</u> collected by the federal government. This appears in stark contrast to trends around youth use of illegal disposable vapor products, which NYTS data shows increased 840% over that same four-year period.

Juul Labs invests in medical-device-quality, American manufacturing. Juul Labs
manufactures its e-liquids, and fills, assembles, and packages its pods in the United States.
We hold ourselves and our suppliers to the highest manufacturing and quality standards,
including obtaining certifications by the non-governmental International Organization for
Standardization (ISO) to create a supply chain comparable in quality to what's found in the
medical device industry.

Juul Labs' Efforts to Combat Underage Use

A core element of a well-regulated vapor marketplace is a system that enables the sale of legal products to adult smokers while simultaneously combating underage use. Our Underage Use Prevention efforts are multi-pronged and are underpinned by new product innovation and programmatic interventions. These include:

- Supporting Tobacco 21 laws. As lawmakers in Florida will recall, Juul Labs actively supported state and federal laws to increase the legal age for sale of tobacco products to 21 from 18.
- Restricting flavors to tobacco and menthol. By November 2019, Juul Labs had pulled all of
 its non-tobacco and non-menthol flavored products from store shelves, months prior to the
 FDA regulation mandating the same for all pod-based vapes.
- Limiting the number of products consumers can buy at one time. Juul Labs limits the number of its products that consumers can purchase in one transaction in an effort to mitigate social sourcing by youth.
- **Enabling retail partner compliance**. Juul Labs supports the non-profits We Card and TruAge, which are designed to increase ID checking at points of sale through store employee trainings and new technology.

Submitting a locked menthol product application to FDA. In December 2023, Juul Labs submitted an application to the FDA to sell in the United States our next-generation device and menthol-flavored pods requiring user age verification — meaning consumers will not be able to use menthol-flavored pods with our next-gen devices unless users verify with the devices themselves that they are at least 21 years old. This represents the first to our knowledge fully age-gated vapor products to be submitted to FDA for review.

A Rampant, Illegal Vape Market Undermines Regulatory Progress

Florida is the number one destination for sales of illegal vapor products in the U.S., most of which are imported illegally via Florida ports from China, and are sold with youth-appealing packaging and flavors.

We would be happy to provide any Florida Legislator with further evidence of this influx and how these manufacturers shirk the law while continuing to illegally target minors, even after repeated FDA warnings to stop sending shipments to the States.

Below are highlights of the data we can provide upon request:

 The FDA sent 37 warning letters to several Florida retailers between May and June of 2023 – including many gas stations and vape shops – for selling blackmarket, illegal vaping products from China.

- FDA Warning letters went to retailers in Clearwater, Boca Raton, Boynton Beach, Coral Springs, Delray Beach, Destin, Fort Lauderdale, Hialeah, Hollywood, Homestead, Lake Worth, Lakeland, Lantana, Margate, Melbourne, Miami Gardens, Miami Lakes, Miami, Mulberry, Mulberry, Oakland Park, Orlando, Palm Bay, Port Orange, St. Johns, Tampa, and West Palm Beach, FL.
- In December, the FDA and the Department of Justice <u>filed a complaint</u> for a permanent injunction against a company based in Florida, for manufacturing, selling, and distributing unauthorized e-cigarette products.
- U.S. Customs and Border Protection confirmed 13 product seizures in the state of Florida valued at over \$6.8M – all of which were imported from China or Hong Kong.
- Florida has the highest sales of these mostly-foreign-made products in the United States.
- Indeed, the Florida Ports Council and Florida Retail Federation already sent formal letters
 of their own to alert the public and federal officials to the threat of illegal China vapes.

"In only two years, a small, colorful vaping device called Elf Bar has become the most popular disposable e-cigarette in the world, generating billions in sales and quickly emerging as the overwhelming favorite of underage U.S. teens who vape.

Last week, U.S. authorities publicly announced the first seizure of some of the company's products, part of an operation confiscating 1.4 million illegal, flavored e-cigarettes from China. Officials pegged the value of the items at \$18 million, including brands other than Elf Bar."
